Minutes 3 February 2014

The regular meeting of the College of Education Curriculum Committee was held on 3 February 2013 at 12:00 P. M. in the Dean's Conference Room (EBA 342). The Co-Chairs were present. Members present were André J. Branch (Co-Chair), Marjorie Olney (Co-Chair), Bernie Dodge, Soh Leong Lim, Cristina Alfaro, Regina Brandon (for Anne Graves), and Cynthia Uline.

José Luis Alvarado made an announcement regarding the uploading of course syllabi. He also announced that he would no longer regularly attend the COE Curriculum Committee meetings, but would attend if requested by the committee.

Cynthia Uline made a motion to approve the minutes of the December meeting. Cristina provided the second. Motion carried.

Cristina Alfaro made a motion for approve the agenda. Cynthia Uline provided the second. Soh Leong offered an amendment that the agenda reflect the correct name of the course for ED 852: "Quantitative Methods of Inquiry. The amendment was accepted and the motion carried.

Bernie Dodge moved that the proposal for ED 852 be approved
Cynthia Uline provided the second.

Cynthia Uline offered the following friendly amendments:

Item #13 be modified to make the course offered as "irregular."

Item #12B- the wording, "or equivalent" should be added.

Item #23B program change form has not been submitted, but it needs to be submitted

Item 23E should list the other departments who would be offering the course: SDSU/CGU Joint Doctoral Program; Ed.D. in Educational Leadership; Math Ed. Ph.D., Ed. Specialist in Educational Psychology.

Motion to include the amendments carried. Main motion to approve the proposal carried.

Cynthia Uline moved for approval of ARPE 853. Cristina Alfaro provided the second. Bernie Dodge offered the friendly amendment that the departmental designation be changed to "ED." Marjorie Olney offered the following friendly amendments:

Item 12b – the wording, "or equivalent course" should be added.

Item 13 – change to "irregular"

Item 23E should list the other departments and/or programs that would use the course: SDSU/CGU Joint Doctoral Program; Ed.D. in Educational Leadership; Math Ed. Ph.D., Ed. Specialist in Educational Psychology.

Bernie Dodge offered the friendly amendment that "compliment" be changed to "complement" in the "Presentation of findings" section of the syllabus. The motion to accept the amendments carried. The main motion to approve the course carried.

Soh Leong Lim moved for approval of the Change in Program proposal for ARPE. Regina Brandon provided the second. Cynthia Uline provided the following friendly amendments:


Pursuant to item #8, there must be letter from SPED

Cynthia Uline provided the second. Motion to approve the proposals carried.

The committee having addressed all agenda items, Cynthia Uline moved that the meeting be adjourned. The motion was seconded by Soh Leong Lim. The motion carried.
