Tamara Collins-Park moved to approve the minutes. Andre Branch seconded the motion. Motion carried.

Tamara Collins-Park made a motion to move the review of the new program proposal for Bilingual Authorization to the end of the agenda. Soh-Leong Lim seconded the motion. Motion carried.

Anne Graves made a motion to review the Academic Literacy Development for English Language Learners course reinstatement. Marjorie Olney seconded the motion. Motion carried.

Anne Graves made a motion to approve the DLE 652 Academic Literacy Development for English Language Learners course reinstatement with the following changes:

In justification, add the word "program" after MA.

Change the ampersand to "and" in the "justify level of course" section.

Motion carried.

Tamara Collins Park made a motion to approve the certificate program change.

André Branch offered the friendly amendment that the name of "Greg Wilson" be removed.

Marjorie Olney offered the friendly amendment that the spelling of "Preparation" be corrected.

Motion carried.

Anne Graves made a motion to approve the SPED 527, Special Education in a Pluralistic Society proposal.

Tamara Collins Park offered the friendly amendment - "Previous/concurrent enrollment in SPED 500, or admission to MA Program with Special Education concentration.

Soh Leong Lim made a motion that the Curriculum Guide should address directly the splitting of courses. Anne Graves seconded the motion.

Motion carried.

Tamara Collins Park made a motion to approve the DLE Basic Certificate Bilingual Authorization proposal. Anne Graves seconded the motion.

Anne Graves offered the following friendly amendments:

First, that appendices not be included.

Second, that a statement be included that items on page 170 of the Curriculum Guide are on the Proposal Entry Form, but not in the order presented on page 170.

Amendments were seconded and accepted by the original mover.
Original motion defeated.

Marjorie Olney made a motion to table the DLE Basic Certificate Bilingual Authorization proposal until the November meeting. Soh Leong Lim seconded the motion. Motion carried.
